FOOD FACTS REESE PEANUT BUTTER CUPS

- Dairy farmer H.B. Reese, an employee of The Hershey Company, invented the candy in his basement in 1928.
- The candy was initially sold for one cent each and were initially named "Penny Cups".



- The Reese Candy Company was created, with the initial offerings being the Lizzie bar (chocolate and caramel) and the Johnny Bar (chocolate and molasses).
- During WWII, rationing of chocolate and other candies proved difficult for some candy companies, but peanut butter was not rationed. This proved to be a boon for the Reese Candy Company. Production stopped on the other candies, and the focus was on the peanut butter cups.
- The Hershey company bought the Reese's Candy Company in 1963 after H.B. Reese passed away.
- Another product that boosted sales for the Hershey's/Reese's brand was Reese's Pieces, introduced in 1978. Hershey's answer to M&Ms.
- Reese's Pieces got more popular when they were featured in the E.T. movie ... being E.T.'s favorite snack, after M&M/Mars declined the offer from Steven Spielberg to be in the movie.
